The District Instructional Leadership Team (Krista Pugh, Heather Howland and Abby Weiland) presented FAST screening data for Kindergarten through 9th grade. Growth from winter of 2021 to winter of 2022 was compared. District MTSS (multi-tiered system of supports) was explained.

Overall the district has seen great growth in the area of math and some growth in literacy. The district continues to work on addressing lost instructional time and opportunities due to COVID. The widespread impact on student learning and mental health are more evident this year than last and the district is working to address identified needs. The areas of need for the district are similar to those across the state.

Superintendent Meaney discussed the FY 23 budget and timeline with the Board.
