Public Comment – Ben Medbourn thanked the Board for the pay increase in FY 2021-22. Ben discussed Paraprofessional pay with the Board. He gave the Board a pay comparison from districts in our area and median pay from the Bureau of Labor Statistics. He gave personal testimonies from employees including job duties and struggles in their jobs. Ben indicated that the pay for paraprofessional is not comparable to duties and responsibility. Board President Barbara Reid thanked the staff for sharing their experiences and concerns in the paraprofessional jobs.
